Call to order

Minutes

Updates

- 1. Celeste has posted suggested badge colors to everyone today, which is the last step before ordering. A quorum has been reached and the order will be placed.
- 2. YLP will lead a multi-networker which will be primarily sponsored by The CBE and Levy Restaurants. We are presenting to NY Life, State Farm, Farmers Insurance, KC Chamber, CXL, and TMC for sponsorships. The event will be on Thursday, May 29 from 5:30-7:30 p.m. and will include food and drink. A DJ is also being considered. Danny is helping Celeste finalize the groups to be invited, and then we will submit for sponsorship requests. We will cap the event at 300 people. We will be capping the event so many tickets/group, and for YLP only paying members will be invited. YLP will not be limited, all paying members can attend. We may determine to keep the event to the second floor. Celeste has asked for multiple cases of MillerCoors product for this event (what we have allotted for socials) and in addition Edgar will try to get extra.
- 3. Celeste will follow-up with Edgar regarding the multi-networker and a sponsorship from Farmers in addition to extra beer.
- 4. NY Life is very in support of supporting watch parties for World Cup, as well as funding professional development.
- 5. Top three goals for Board members is something Edgar doesn't want to lead, keeping in mind succession training.
- 6. The Pay Pal account cannot be updated, yet. We are buying an iPad mini for membership, but we need to complete a check request, first. We can use the square, alternatively to Pay Pal. We are concerned there are not consistently tables or people working to take payment. We would like to submit a change to the event request form, wherein the committee facilitating the event must denote the specific person(s) who will take membership costs. This person must be able to use a square. Eventually, we will have an iPad mini for square use at events. Edgar has asked Manny to develop a Policy regarding responsibility for taking payment (ie: committee organizing or membership committee). Edgar will set up the square account with the iPad. Manny will get us extra Squares.
- 7. For this month's social, we'd like to have a designated section to control our group / take payment.
- 8. Philanthropy is reaching out for volunteers from YLP for GCI Fiesta. We need to forward invitations for the run. We also would like to have Teams running. The Board has agreed will we be a team and run/walk.
- 9. Celeste and Andrea have been attending weekly Fiesta KC meetings and Margarita Cove committee will meet the second and fourth Mondays at 6.
- 10. Spider banners are \$50 each, Danny moves we should buy two, and it was agreed upon. Shannon will obtain a table runner.
- 11. Retreat date was chosen, but then we learned it needs to be rescheduled, and Edgar will take responsibility.
